

**Sangini** in Hindi means 'a friend'. It is a women led, multi-cultural women's organisation with a focus to

*'improve the quality of women's lives by increasing their physical, mental and spiritual health and well-being, through artistic, educational, cultural and recreational activities that also celebrate cultural diversity'.* 

#### Background

Set up in 2002 by a group of women who were concerned about the health and wellbeing of disadvantaged women in Sunderland, today Sangini has evolved into an organisation with credibility, vision and capacity to deliver its work to highest professional standards.

Our values are centered on the following:

- The well being and health of all women
- Empowering and uplifting minority women and excluded women
- Learning, enjoyment, creativity and development through the arts
- Promoting inclusion, integration and participation through the arts
- Challenging the inequality and invisibility of women
- Making a difference

#### Our vision:

There will be increasing number of empowered BME (Black and minority ethnic) women and other currently excluded women involved in all aspects of civil and civic life, they will be influencing policies and recognised as decision makers in the mainstream.

#### **Governance and delivery**

Sangini's **governance** is led by a diverse group of leading women from different social, cultural, ethnic and professional backgrounds who provide crucial strategic direction for the overall work. The range of expertise varies from community development, mainstream healthcare provision, the cultural sector to sustainable development. The level of experience represented includes high level project management, strategic planning, financial management, business planning, fundraising and policy advocacy. It is this collective experience that we aim to draw upon when we develop and deliver our activity.

The **effectiveness of delivery** is maintained by monitoring and evaluating all the projects, and provides essential lessons learnt for the next phase of the development.

All the work is designed and delivered in **partnership** with its users, stakeholders and wider community groups, thus harnessing good working relationships across the sector.

## Activity during 2010 – 2011 and Future plans

The following provides a brief overview of activity that Sangini undertook during 2010 – 2011:

- Shakti an 18months project involving various artists. This project is about domestic abuse against women in Sunderland
- Sunderland Festival of Light: Diwali celebrations Sangini's annual activity
- International Women's Day
- Multi Cultural day at Sunderland Library
- Employment Access Project a research as well as a project that Sangini did in partnership with the Sunderland BME Network.

Future activities include Melting Pot – a cookery and art project with women in Sunderland and Sisters of Sunderland – a heritage project that aims to capture the life stories of women from diverse backgrounds in Sunderland

### **Responsibilities of the Trustees**
